2. The People's Bank of Zanzibar Limited has set aside funds for its operations during the financial year 2015. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for several services and supply in the bank premises in Zanzibar and Mainland Tanzania as described below:

All Tenders in one original plus Two copies, properly filled in, and enclosed in plain envelopes marked "**Tender No: PBZ/2015/... lot number for(Please specify)**", must be delivered to the **Secretary of Tender Board, The People's Bank of Zanzibar Limited Tender Board, Head Office Building, Darajani - Zanzibar.**
6. Deadline for submission will be on **16th June, 2015 at 2:00 pm hours** local time at the Head Office Building, Darajani, Zanzibar. Tenders will be opened promptly thereafter in public and in the presence of bidders representatives who choose to attend in the opening at the conference room, PBZ Islamic Banking Head Office -Mpirani, Zanzibar.

A complete set of Tender Document in English and additional sets may be purchased by interested Tenderers on the submission of a written application to the address given under paragraph 6 above and upon payment of a non-refundable fee of TZS 100,000.00 for Tender documents. Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to the People's Bank of Zanzibar Limited, account name, Tender Commitment Fees, account number 41020125.

8. All Tenders must be accompanied by Tender Security amounting Tzs 1,000,000.00 in acceptable format.
9. Late, partial and electronic quotations, and quotations not opened at the quotation opening ceremony shall not be accepted for evaluation irrespective of the circumstances.
